- Homeowners presented questions & discussion topics regarding personal

We do currently have a disclosure fee of \$400 due at the sale of the home from the sellers. This is set at the maximum amount allowable. Our CC&Rs do not currently give us the ability to assess a transfer fee. We would need to amend our CC&Rs to have the section ability added and it would need to be approved by the community.
